### PRP CRITERIA REAL ESTATE € 250,000 +VAT

Payment of the purchase price to our account in Greece by bank transfer.

### PAYMENT & SUBMISSION

1. Payment of the purchase price to our account in Greece by bank transfer;
2. The transfer should be made through the personal account of the Applicant and/or the corporate account of a company that he/she is signatory;
3. Authorisation to submit the application and to receive the cards via the legal Representative.



\*Greek Authorities issue a receipt of application which may be used as a temporary permit prior to residence being granted.

### PRP CRITERIA REQUIRED DOCUMENTS

1. Application form + fee;
2. Four recent colour photos (4X6) and digital images on CD;
3. Certified copy of a valid passport;
4. Valid Visa type C;
5. A residence permit - electronic fee (€500 for a five-year permit);
6. Cost of single document permit - blue certificate €16;
7. Private Health Insurance policy;
8. Official Certificates (Marriage, Birth Certificates).

### GOLDEN VISA EXAMINATION

Only **2 MONTHS** examination period

### APPROVAL

Visit Greece once for Biometrics after the Approval of Application.

### FINAL VERIFICATION BIOMETRICS



1. Once the Application has been verified and approved, biometrics will be required based on a **scheduled appointment**
2. Issuance of Cards in **15 days**
3. Applicant then acquires Greece Permanent Residency and Schengen Visa
